



General terms & CONDITIONS

REGISTRATION

For a registration to be validated by Pro Dunes Events, S.L., a company of Andorran law located at Carretera d'Engolasters, 53, Edif.3, Àtic 3, AD700 Escaldes Engordany, Andorra you must:

- Fill out your entry form on the rally's website: www.rallyedumaroc.com (competitors tab / sign up)
- Make the deposit, corresponding to the pre-commitment fees, and in respect to the payment schedule.
- Register all the requested documents by **September 11, 2026**.
- Be 18 years of age on 26/09/2026
- Be under 60 on 26/09/2026 for all FIM categories.
- Be in possession of a sports license corresponding to your category.
- Have proof of and be in possession of a valid driver's license appropriate to your vehicle. Documents attesting to the loss or theft of a driving license will not be accepted.
- Have the corresponding authorization from your National Motorcycling Federation (FMN) or your National Automobile Federation (FAN). (this authorization can be included in your licence, please ask your federation)
- The Organizing Committee reserves the right to refuse the registration of any team, member of a team, competitor or media person.
- Registration will not be final until the payment of the full registration fee has been made.

DISCLAIMER OF LIABILITY

Each registered participant in the Rallye du Maroc 2026 is fully aware of the risks involved in participating in a competition of this type. Each registered participant exonerates, from this moment on, the company Pro Dunes Events, S.L, its representatives, employees, and/or any person acting on its behalf, the Organizers, the ROYAL MOROCCAN FEDERATION OF AUTOMOBILE SPORT (FRMSA), the ROYAL MOROCCAN FEDERATION OF MOTORCYCLISM (FRMM), the INTERNATIONAL FEDERATION OF AUTOMOBILE (FIA) and/or the INTERNATIONAL FEDERATION OF MOTORCYCLISM (FIM), of all criminal or civil liability in the event of a physical or material accident as a result of participation in the Rallye du Maroc 2026 and/or in case of damage occurring in the competition and/or to assistance vehicles.

REGISTRATION RIGHTS

All participants wishing to enter the Rallye du Maroc will have to pay the entry fees that will follow on our website.

CONDITIONS OF CANCELLATION

In the event of cancellation by a participant, fees paid to date will be transferred in your name for registration in the 2027 edition of the Rallye du Maroc or we can offer the following:

- 1) Before July 15 2026, 100% of the fees paid to date will be refunded (except the bank fees and the administration fees).
- 2) From July 16 to July 11 2026 : 70% of the fees collected will be reimbursed (except the bank fees and the administration fees).
- 3) From August 16 to September 11 2026 : 50% of the fees collected will be refunded (except the bank fees and the administration fees).
- 4) As of September 11st, 2026, no refund will be made.

PAYMENT

The organization will accept only one payee per vehicle and/or per team. The payment must be made exclusively by bank transfer. **Please indicate your file number, including the reference RDM2026, when making a bank transfer.**

If you fail to comply with the payment schedule corresponding to your rate then you will automatically be redirected to the higher rate.

BILLING

A single invoice will be issued for the services offered by Rallye du Maroc, duly detailed at the address and name provided by the Team. In no case may different individuals or legal entities be billed for the same registration.

You will find your invoice on the registration platform a few weeks after the end of the rally.

PROHIBITION TO START

If as a result of the administrative and/or technical checks, a Team or vehicle is prohibited from starting the race, it cannot claim a refund of the amounts paid for any reason.

In the event the Rallye du Maroc has to be reorganized at a later date or cancelled, regardless of the reason, be it attributable to the organization or not:

1 - If the Rallye du Maroc is cancelled and reorganized at a later date:

- The paid entry fee will be retained by the organization with no refund. Customers will have the right to take part in one of the next two editions of the Rallye du Maroc. The amount already paid will be deducted from the entry fee of the chosen edition.
- Hotels and charters will be reimbursed in accordance with the General Terms and Conditions of Sale of the service providers.

2 - If the Rallye du Maroc is cancelled and not renewed:

- A refund of the amount already paid, less a 25% administration fee will be rewarded.
- Hotels and charters will be reimbursed in accordance with the General Terms and Conditions of Sale of the service providers.

GPS, Iritrack, Balise:

The rental of this security equipment is not included in the entry fees as well as the purchase of the fixture kits and accessories for this equipment. You must order them directly from the service providers (order forms are downloadable from the website).

It is imperative that the kits be installed before the start of technical checks and that the electrical connections be operational. For each piece of equipment, a deposit will be required at the time of the administrative checks by the service provider in order to guarantee restitution or repairs in the event of damage.

INSURANCE

It is the responsibility of the participants to ensure that the insurance of their vehicle is valid in Morocco.

ACCOMODATION

You can make your accommodations package reservation for the city of departure and arrival and the Moroccan desert at the bivouac through our website www.rallyedumaroc.com where you will be directed to a third-party provider.

TRANSPORT

The transportation of vehicles and competitors, to and from the Rallye, is not included in the entry fees.

RIGHT TO IMAGE AND INTELLECTUAL PROPERTY

The participants of the Rallye du Maroc 2026, organized by Pro Dunes Events, S.L, understand that it is a promotional event from which they can benefit by the recognition acquired during their participation.

As such, the company Pro Dunes Events, S.L holds all rights necessary for the production and broadcast, by any means and in any medium, throughout the world, of images and sounds relating to this event.

Participants are not authorized to use the registered trademark "RALLYE DU MAROC" nor the domain names "rallyedurmaroc.com", rallyemaroc.com" "rallyemaroc.fr" and "rallyedumaroc.fr" without the written authorization of Pro Dunes Events, S.L.

In order to allow the greatest possible circulation and promotion of the RALLYE DU MAROC 2026, any person participating in any way in the RALLYE DU MAROC 2026 is subject to its regulations and acknowledges that their participation in the event authorizes the organizer and any person designated by the latter to reproduce and represent, without any kind of remuneration, their names, voices, images, biography and in general their sports development in the RALLYE DU MAROC 2026 in the same way as the brand of their equipment suppliers, makers and sponsors, in any way and format, existing or future support, for any communication to the public throughout the world, for any use, including advertising and/or commercial purposes, without limitations and for a minimum period of 10 years.

Participants transfer to Pro Dunes Events, S.L, on behalf of their sponsors and/or the maker of their vehicle, the right to, within the framework of the exploitation derived from the event, including the sponsors and means of the event, reproduce totally or partially, at the discretion of the organizer, in any existing or future support, throughout the world, without limitations, for a minimum period of 10 years, the brand names or logos of said sponsors and/or visuals of said vehicles.

All participants are informed and accept, unequivocally and expressly, that their personal data will be processed and will be part of the “concurrents” file managed by Pro Dunes Events, S.L, the purpose of which is to collect information for security and communication with competitors. The only recipients of this data are the managers of Pro Dunes Events, S.L. Any participant may exercise his right of access, deletion and opposition with Pro Dunes Events, S.L, under the legal conditions of the application.

Applicable LAW AND COMPETENT JURISDICTION

The present condition of registration and in general any contractual relationship agreed upon between Pro Dunes Events, S.L and any participant are governed by Andorran law. The Andorran courts will be the only ones competent in the event of any litigation relating thereto.

COLLECT INFORMATION

In the context of my participation, I agree that the Organiser may pass on my data to its subcontractors and to any authority that may request it, and that the Organiser may collect information about me, in particular by means of polls, surveys or questionnaires for the purpose of improving the services offered.

CODE OF CONDUCT

Any person taking part in the Rallye du Maroc 2026 in whatever capacity commits to abide by the present Code of Conduct which reflects the values of the Rallye du Maroc.

By taking part in the Rallye du Maroc, I undertake to abide by the customs of country, its inhabitants and the sites passed through.

My behavior shall be responsible and respectful of the environment, by observing selective collecting (glass and plastic waste in yellow dustbin, organic waste in green dustbin), sensitive residues collecting (used oils to be collected in the collect point on the bivouac), cleanness of the race route (no waste left on the route even after repairs) and signage of presence of archeological sites and/or sensitive environmental zones.

I shall always favor my own safety and that of others in all circumstances, and shall adopt at any moment a proper behavior in order not to endanger persons. In this regard, should I be submitted to the Event Regulations, I certify that I read the safety rules set out therein in particular those relating to speed control and limitation and crossing of inhabited areas. I am aware that no competition state during the race shall justify my not giving absolute priority to the safety of persons.

I am aware that no competitive situation during the course of the race would justify me not giving absolute priority to the safety of people.

I undertake not to allow anyone under the age of 18 to enter the bivouacs or service parks.
